---

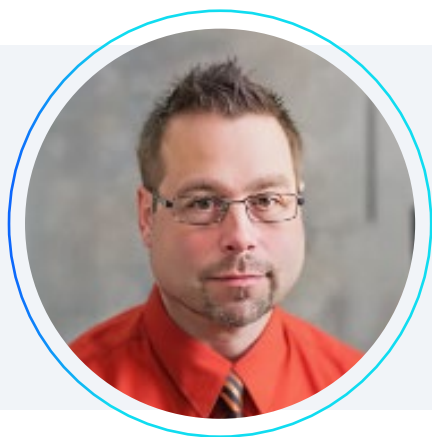
The Jefferson County Clerk's Office serves as the cornerstone of public record-keeping and citizen services for Kentucky's largest county. With a rich history dating back to the 1700s, the office maintains vital records, including marriages, deeds, and mortgages, while processing approximately 700,000 vehicle registrations annually.

The office provides comprehensive services, including legal records management, motor vehicle registration, election administration, and business licensing.

Under the leadership of County Clerk Bobbie Holsclaw, the office embraces a VIP (Value, Integrity, Performance) service approach, combining traditional record-keeping responsibilities with modern digital innovations. From managing millions of historical documents to providing online registration renewals and implementing anti-fraud measures like ClerkAlert, the office continues to evolve its service delivery while maintaining its foundational role as "keeper of the record."

The Information Technology division serves as the technological backbone of operations, managing a sophisticated network that connects 13 locations and supports 274 employees.

The IT team maintains critical infrastructure, including computers, networking, point-of-sale systems, and specialized government software, while ensuring seamless integration with statewide systems.
